

Privacy Policy

I. Purpose

Azul Services has created this privacy statement in order to demonstrate our firm commitment to privacy. The following discloses our information gathering and dissemination practices for Azul Services websites, including all sub-domains as well as any applications used to access our hosting services.

II. Scope

This privacy statement only covers the information collected on Azul Services' web sites. The Azul Services' web sites contain links to other sites. Azul Services is not responsible for the privacy practices, actions, or the content of such web sites.

III. Children's Guidelines

Azul Services requires that all account holders be 18 years of age or older. Children are not provided access to any Services services in which any personal data is collected beyond the collection of a visitor's IP address and session status.

If Azul Services becomes aware that any child has accessed Azul Services' non-publicly available web sites, the account through which the child has gained access will be terminated.

No information should be submitted to or posted at Azul Services web sites by persons under 13 years of age. Azul Services does not knowingly collect personal information from children under the age of 13. All Azul Services services are open only to persons over the age of 18.

If you believe Azul Services has collected any information from or about anyone under 13, please contact us immediately.

IV. Information Collection

Our web sites use on-line order forms for customers to request services. Through these order forms we collect your contact information and financial information. Your contact information from the order forms is used to contact you regarding the status of your account and to send you information about Azul Services services available. Financial information that we collect from you is used to bill you for your Azul Services account services.

Azul Services web sites also log IP addresses and other user session information to help diagnose problems with our servers, to administer and improve our web sites, to facilitate marketing of Azul Services products, and to gather broad demographic and statistical information.

V. Cookies

Azul Services web sites use cookies to retain your session state during your logon to the applications used to access our hosting services. You may opt out of the use of cookies by turning them off in your web browser. However, the use of cookies is necessary for the use of Azul Services's application used to access our services.

VI. Public Forums

Azul Services sites make chat rooms, forums, message boards, and news groups available to its users. Please remember that any information that is disclosed in these areas becomes public information and you should exercise caution when deciding to disclose your personal information.

VII. Information Dissemination

Azul Services will release personally identifiable information about you as is reasonably necessary for the provision of Azul Services services for which you have subscribed. This includes, but is not limited to:

- provision of financial information to organizations such as Cybersource, VeriSign, PaymenTech, Signio and CyberCash for Azul Services billing purposes,
- provision of contact and software usage information to our software license providers for the purpose of software licensing compliance, licensing usage calculation, and billing purposes
- provision of your account information to independent contractors providing services in support of Azul Services's delivery of services to you. (Note: all independent contractors to whom Azul Services provides account information are required to sign a non-disclosure agreement).
- transfer information that you provide to apply for separate software licenses through Azul Services such as Miva Merchant. The information you provide to Azul Services to apply for separate software licenses or directly to the software licensor will be subject to the privacy policy of the licensor and not this Privacy Policy.

In addition, Azul Services may release personally identifiable information necessary for the prosecution or defense of any legal claim or right to which Azul Services is a party. Azul Services will also release personally identifiable information as required by law.

VIII. Security

Azul Services's web sites have security measures in place to protect against the loss, misuse, or alteration of the information under our control. Your contact and financial information is submitted via a secure (HTTPS) connection and stored in the Azul Services database protected by a firewall. Access to your information is restricted to authorized Azul Services personnel and contracting partners only.
